Fee/Program Time: We agree to pay to **Whitetail Acres \$1,400.00 plus \$3.50 per mile one way, 61 miles \$213.50 for a total of \$1,613.50** for the “Reindeer Experience” program on **Wednesday, December 21, 2022 for the hours of 6 PM – 10 PM**

- Service Description:** We understand that **Whitetail Acres agrees to provide one or two reindeer** in halter and lead-ropes on-site at **City of Charlestown/Greenway Park** for the time period indicated above. The reindeer will be confined to a corral area (approximately 12’ in diameter), in a mutually agreed upon area. **Whitetail Acres** will provide 1(one) or (two) handler(s) for the purpose of leading and supervising the reindeer while on-site in the corralled area. The handler(s) will be with the reindeer at all times. At no time will the reindeer be released to anyone other than the handler(s). **Whitetail Acres** must restrict the petting of the reindeer, while on-site, by guests unless approved by the handler(s). The handler(s) will be available to answer questions regarding basic history and reindeer lore during the event. Of course, they will be able to answer the most important question of all, **“Do they really fly?”** **Whitetail Acres** handler(s) will be responsible for removing any excrement left by the reindeer following the event.

2. **Deposit: We agree to pay a non-refundable deposit of 50% \$806.75 by March 31, 2022.** This deposit will be applied to the final bill which is due in full on the date of the event.

3. **Supervision:** We understand that **Whitetail Acres** facilitators and/or its guest presenters will be with the reindeer at all times. The reindeer are required to remain in the corral area at all times. Likewise, it is the responsibility of the parents/guardians of the children present to be responsible for the children under their supervision.

4. **Liability: City of Charlestown/Greenway Park and Whitetail Acres** hereby mutually agrees to indemnify, defend, including attorney fees, and hold harmless the other party from any and all claims for injury and damages arising from the performance of this contract which are attributable to negligent acts of the other party including their owners, employees and agents.

5. **Weather:** We understand that **Whitetail Acres** has no control over the weather. We understand that regardless of the weather (including rain and snow), the event will be held outside. The "Reindeer Experience" operates in all weather unless the weather conditions are deemed to be dangerous by the **Whitetail Acres** manager.

6. **Facilities:** We understand that **Whitetail Acres** will be utilizing **Greenway Park** facilities. **Whitetail Acres** will provide a portable corral area for the purpose of containing the reindeer and their handler.
