Councilman Cox made a motion to approve the agenda, seconded by Councilman Steele. Approved 5-0.

Minutes, Claims and PR Voucher

Councilwoman Jackson made a motion to approve the Minutes of 12/05/2022, the Claims and the PR voucher from 12/04/2022 to 12/25/2022, seconded by Councilman Hester. Approved 5-0.

Public Hearing

Mayor Hodges opened the public hearing considering the Preliminary Engineering Report for the City of Charlestown Wastewater Treatment Plant Expansion. There was no discussion. Mayor Hodges closed the public hearing.

Resolution 2023-R-01

Resolution 2023-R-01 approves the Preliminary Engineering Report for which we just had the public hearing.

Resolution 2023-R-02

Resolution 2023-R-02 approves the authorized representative for the SRLF Program. JTL will be authorized to submit to the SRLF on behalf of the city. Councilman Hester motioned to approve Resolution 2023-R-02, seconded by Councilman Steele. Approved 5-0.

With the advice of Attorney Gillenwater, Councilwoman Jackson makes a motion to table Resolution 2023-R-02 until the language in the resolution can be changed to not grant JTL full control of signing for the loan, seconded by Councilman Hester. Approved 5-0.

Ordinance 2023-OR-01

Ordinance 2023-OR-01 amends Ordinance 2016-OR-19 Zoning Ordinance. Tony Jackson asked the council to wait on this resolution until the next meeting so that Attorney Gillenwater can correct some of the verbiage.

Councilman Steele motioned to table Resolution 2023-OR-01, seconded by Councilman Cox. Approved 5-0.

New Business

Councilman Cox nominated Ruthie Jackson as Council President, seconded by Councilman Steele. Approved 5-0.

Councilwomen Jackson motioned to approve Attorney Mike Gillenwater's Contract for 2023, seconded by Councilman Hester. Approved 5-0.
