RESOLUTION NO. 2012-R- 4

**A RESOLUTION ADOPTING A REDEVELOPMENT/REVITALIZATION PLAN
FOR AN AREA WITHIN THE CITY OF CHARLESTOWN, INDIANA**

WHEREAS, the City of Charlestown, Indiana (the "City of Charlestown") is authorized by Indiana Code § 36-7-2-1et seq. to plan for the use, improvement and maintenance of real property and by Indiana Code § 36-7-2-7 to promote economic development in the City of Charlestown;

WHEREAS, on October 22, 2012, a Redevelopment/Revitalization Plan for a certain area located within the City of Charlestown community (the "Plan"), depicted on "**Exhibit A**", attached hereto and incorporated herein, which area is roughly bounded as follows: on the north by Highway 403, on the east by Highway 3, and on the south and west by the edges of Pleasant Ridge subdivision, was Plan presented to the Common Council of the City of Charlestown (the "Common Council") at a public hearing/meeting; and

WHEREAS, the Common Council has considered the Plan and related public comments and determined that the Plan is in the best interest of the City of Charlestown and its residents; and

WHEREAS, the Plan is supplement to, and not a replacement for, the presently existing Comprehensive Plan for the City of Charlestown and is a plan containing goals, not mandates, for the City of Charlestown.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Charlestown, Indiana, that:

1. The Charlestown Community Redevelopment/Revitalization Plan attached hereto as Exhibit A, and incorporated herein is hereby approved and adopted.
2. This Resolution shall be in full force and effect from and after its passage and approval by the Mayor.
